### **SHERR Communities of Practice and Action Update**

SHERR Communities of Practice and Action (CoPAs) are nearing the half-way point of their collaborative work. The four groups include representatives from higher education institutions and resettlement agencies and affiliates, as well as federal and state government representatives. They have been busy mapping out existing resources and identifying areas where resources are most needed to help campuses engage with refugees along the four topic areas. In this update, we share the major highlights and insights from the third round of sessions and as always appreciate the contributions and support of our group members.

### English Language Learning and Career Pathways Support (Facilitator: Olga Prizhbilov, Los Rios Community College District) | Session 3: May 7, 2024

- The group reviewed teaching curricula and effective teaching practices most commonly used when teaching refugee students; we discussed materials and approaches for teaching emergent learners (also referred to as preliterate learners) as well as highly educated/advanced level learners;
- Guest speaker Ariana Moir of <u>The Immigrant Learning Center, Inc.</u> presented some of their resources for immigrant and refugee students;
- Using information collected collaboratively, the group will create a toolkit with a listing of best curricula and teaching approaches and resources that can be used in support of refugee-focused ELL & Career Pathways programs. When completed, this toolkit will be made available on the Refugee Resource Hub.

### Housing and Campus Utilization (Facilitator: Dr. Diya Abdo, ECAR) | Session 3: May 6, 2024

 The group discussed various types of partnerships and forms of stakeholder engagement when seeking to offer housing for refugees on campus;

- The meeting featured a presentation from Leon McClinton, Director of Housing at Oklahoma State U and past
  president of the <u>Association of Campus and University Housing Officers</u>; the discussion included questions about
  messaging points and approaching university leadership, housing officers, and community stakeholders;
- At the next session, the group will review existing campus housing resources from organizations such as ECAR,
   NASH RRI, RWC, and RHS/IRC to ensure that any new toolkits and materials are complementing the existing pool;
   new materials will be made available through the Refugee Resource Hub.

### Educational Opportunities: Reducing Barriers to Enrollment (Facilitator: Marina Chakmakchi, University of Southern Maine) | Session 3: May 8, 2024

- The group compiled possible goals and stakeholders to include in statewide coalitions at the intersection of higher education and refugee resettlement and will dive into how to get started this summer.
- Members continued to discuss funding opportunities and how to ensure the information is accessible to refugee students.
- The group reviewed and shared existing models of refugee student data collection and are exploring solutions to address the general lack of available data.

### Service Learning & Volunteer Engagement (Facilitator: Dr. Carina Black, Northern Nevada International Center @ University of Nevada Reno) | Session 3: May 6, 2024

- The group is exploring how to map service-learning/community engaged learning programs around the U.S., and what would be included and who is the target audience.
- Members learned about opportunities to leverage <u>Community Service Federal Work Study</u>.
- Working in small groups, participants focused on tips for building relationships between higher education institutions and resettlement agencies and community engaged learning.
