SHERR Communities of Practice and Action Update

SHERR Communities of Practice and Action (CoPAs) are back in full swing this fall! We are now transitioning fully to the 'action' portion of our collaboration. Group members, representing higher education institutions and resettlement agencies and affiliates, as well as federal and state government offices, are developing a variety of tools, talking points, guiding documents, and other materials. All resources which are being created by the CoPA groups aim to address urgent resource gaps and help enable greater participation by higher education in resettlement. The process of co-creating resources by all four CoPA groups is an opportunity to harness the collective knowledge of practitioners in order to make it publicly available through the online Refugee Resource Hub, which is being built out under SHERR.

English Language Learning and Career Pathways Support (Facilitator: Olga Prizhbilov, Los Rios Community College District) | Session 5: September 10, 2024

- The group discussed ways in which higher education programs link education and career pathways
- Participants shared their experiences with partnerships, outreach, and maintaining relationships with community partners.
- Working Groups continued collaboration on two resources: *Partnerships Toolkit* and an *ELL Teaching Practices for Adult Refugees Guide*. The group continues to collect information about *Funding ELL & Career Pathways* programs as well as inspirational examples of campuses running successful ELL & Career Pathways programs

Housing and Campus Utilization (Facilitator: Dr. Diya Abdo, ECAR) | Session 5: September 9, 2024

 - Preparing Refugees to Use Campus Housing: norms, practices and culture
- Further, the CoPA continues to collect information about funding sources for campus housing, as well as specific examples of campuses housing refugee families

Educational Opportunities: Reducing Barriers to Enrollment (Facilitator: Marina Chakmakchi, University of Southern Maine) | Session 5: September 11, 2024

- The group discussed and compiled ways in which institutions and programs are engaging and staying connected with alumni.
- Participants discussed how institutions and programs are providing career and professional network support for refugee students.
- We reviewed and are continuing to develop resources on *Building Statewide Coalitions* and recommendations around *Collecting Refugee Student Enrollment Data*.

Service Learning & Volunteer Engagement (Facilitator: Dr. Carina Black, Northern Nevada International Center @ University of Nevada Reno) | Session 5: September 13, 2024

- Guest Presenter- Jessi Kalambayi shared about the <u>University of Denver Ready for Hospitality Program</u>.
- Participants appreciated the mutually beneficial nature of the project for the DU students and the refugee
 participants, having a shared goal/project, and the sustainability of the program through endowed external
 funding.
- Breakout groups identified top 5 Tips for Universities to Partner with Resettlement Agencies (RAs), RAs to partner
 with universities and for RAs and universities to work together related to service learning/volunteer engagement.
